News from the Advisory Board

Advisory Board on Toxic Substances Finalizes Recommendations Before the End of Their Term

The second term Advisory Board on Toxic Substance and Worker Health (ABTSWH) held virtual meetings in April and June. Before their term was over, the Board finalized the following recommendations to the Division of Energy Employees Occupational Illness Compensation (DEEOIC):

- ★ DEEOIC should review the list of job categories the Board developed and expand the Procedure Manual's list of job categories which can be presumed to be exposed to asbestos.
- ★ The Board recommended and DEEOIC agreed to remove Exhibit 18-1 from the Procedure Manual. This exhibit contained a contradictory statement involving smoking history and the presumption for Chronic Obstructive Pulmonary Disease (COPD).
- ★ The Board provided information DEEOIC requested concerning Parkinsonism. They also recommended that trichloroethylene and carbon disulfide be an additional link to Parkinson's Disease in the Site Exposure Matrix.
- ★ The Board finalized their recommendation to include additional cancer-causing toxic substances into the Site Exposure Matrix.


In addition, the Board expressed that it is necessary for them to have a contractor so they can fulfill the work assigned to them by Congress. The Board drafted a preliminary document required by the U.S. Department of Labor (DOL) to justify the Board's need for a support contractor. They currently do not have the capacity to properly oversee the quality of the work by industrial hygienists and contract medical consultants as legislated by Congress. The U.S. DOL has begun the process to seat the third term board, in hopes to appoint the members quickly and avoid any break in the Board work.

New Medical Bill Processing Provider

Changes to your U.S. Department of Labor White Medical Benefits Card

If you have been approved for the U.S. DOL white medical benefits, you should have received the new white medical benefits card in the mail, along with a Welcome Letter. You will notice the information on the card has changed. There is no longer a card ID number to identify your benefit. Instead, you are identified with a case number.

The case number can be found on the front of your new card and

ranges from 4 to 12 digits in length. This case number is the way you will be identified and covered for care under the EEOICP. Please make sure your medical provider(s) have a new copy of this card the next time you visit their office or receive home care from them so they can properly bill for the care you have earned.

Breathing – An Essential Function

Are you ever frustrated that you become short of breath doing everyday tasks like bathing and dressing, or walking up a few stairs? Is it worrisome when you hear that air pollution is going to be poor on any given day? Do you rely on breathing medicines, treatments, or equipment as part of your routine? You aren't alone. Current information suggests:

- ★ Approximately 16 million Americans have been diagnosed with Chronic Obstructive Pulmonary Disease (COPD), examples include Chronic Bronchitis and Emphysema. It is estimated that the true number may be closer to 24 million, if undiagnosed people were included.
- ★ About 25 million Americans suffer from Asthma, putting them at risk for sudden attacks of breathing difficulty as well as more complications from common cold and flu, including COVID-19.



★ An additional 541,000 people are living with some form of lung cancer. There are several types of lung cancer, accounting for 13% of all cancers. The five-year survival rate depends on how early the cancer is diagnosed and treated. Unfortunately, most cases are not caught early.

What can be done for people with respiratory conditions?

After all, breathing is an "essential function." Talk to your doctor about options you may have. If your treatment plan hasn't changed in years, you may be able to access newer medications and equipment. Inhaled medications have come a long way in recent years. Oxygen equipment is available that is smaller and lighter than earlier versions. If you receive in-home care through Professional Case Management, you can talk to your Nurse Case Manager about available options.

Quick and easy tips to make breathing easier:

- ★ If you smoke, quit as soon as you can. Smoking makes every respiratory condition worse. Look into gums, lozenges, or patches. You can also receive free coaching through the national quit line at 1-800-QUIT-NOW.
- ★ Avoid getting sick by practicing good handwashing, limiting visitors and exposure to crowds, and getting a yearly flu vaccine.
- ★ Keep up your strength by eating a balanced diet that includes enough protein, healthy fats, vitamins, and minerals. Including lean meat, fish, and dairy products, as well as plenty of fruits and vegetables.
- ★ Get regular light to moderate exercise, such as walking.

Your health status changes over time – is it time for an impairment evaluation?

Did you know that as a nuclear weapons or uranium worker, you could qualify for even more monetary compensation? To determine if you qualify, you will need an impairment evaluation, which must be performed by a certified physician who is enrolled in the U.S. Department of Labor (DOL) Energy Employees Occupational Illness Compensation Program (EEOICP).

For each 1% of impairment, \$2,500 is awarded, up to a maximum of \$250,000. This benefit is on top of what you may have already earned through the EEOICP and Radiation Exposure Compensation Act (RECA) Programs.

Official Cold War Patriots National Day of Remembrance™

Every October, the Official Cold War Patriots National Day of Remembrance[™] honors the men and women who worked in the U.S. nuclear weapons and uranium industries and recognizes those who are no longer with us. The Cold War Patriots (CWP) community is grateful for the efforts of Janine Anderson, a former nuclear weapons worker, who led the effort to create the first National Day of Remembrance (NDR). Our community was saddened by Janine's passing in 2009, but we remain deeply grateful for her dedication to creating this day that recognizes this group of dedicated workers. The United States Senate first passed a resolution to create NDR in October 2009 and for the past eleven years, at the request of Cold War Patriots, they have passed a Resolution to designate October 30th as the day to remember the work performed by the brave men and women in our nuclear weapons complexes.

In March, we asked Senator Lamar Alexander (R-TN) to introduce the Resolution and Senator Tom Udall (D-NM) to be the lead co-sponsor of the Resolution, as they have done in past years. But this year there will be an added request—*to permanently designate October 30th as the National Day of Remembrance for Nuclear Weapons Program Workers*. Designating October 30th permanently as a National Day of Remembrance for Nuclear Weapons Program Workers will not be considered a national holiday such as Memorial Day or Veterans' Day. Instead, it will be a day much like Flag Day—a day to honor and remember those civilians who helped protect our country.

In June we published the blog, "Let's Make the National Day of Remembrance for Nuclear Weapons Program Workers Permanent!" and asked the public to help accomplish this important goal by signing a petition to send to Senate members. We also sent out a press release, posted on Facebook and emailed our Cold War Patriots members asking them to sign the petition. We received over 1,500 signatures and the petition has been submitted to the Senate.

As we move forward in planning the 12th Official Cold War Patriots National Day of Remembrance[™], we are closely monitoring the Centers for Disease Control (CDC) health regulations and listening to the concerns of our Cold War Patriots members who fall into the at-risk population. We are considering hosting a virtual National Day of Remembrance, which would allow you to participate in the ceremony from the comfort of your own home. Life at Home for Cold War Patriots Members

Cold War Patriots (CWP) knows many of our members suffer from respiratory and other illnesses due to the service you provided for our nation's defense. When the COVID-19 pandemic began we knew we needed to act quickly. Our goals were to continue to keep you informed and check in with as any members as we could in hopes of being a friendly voice you could talk to during a time of limited social interaction.

Since March, thousands of CWP members have joined one of our Virtual Events and our Outreach Team has spoken with members all across the nation. "Every worker I spoke to was beyond appreciative that someone in their community was calling them to see how they were doing and if they needed anything. Many are widowed and living alone, so they wanted to talk and enjoyed hearing a friendly voice that called to check on them and cared," shared Nikki Clark, Local Representative of Cold War Patriots from Paducah, Kentucky.



While some nuclear weapons and uranium workers happily shared personal stories about quarantining with their family and how their pets seemed confused to have them home; many also shared how much they missed weekly breakfasts with friends, monthly bingo games, seeing their grandkids, and wondered if and when life would go back to normal.

Many had questions about their U.S. DOL EEOICP claim and decided to rededicate this time to completing their to-do list. A CWP Outreach Team member was able to assist a member with finding pulmonologists in their area and providing insight into what their next step should be. "Many of these workers had lost all hope," said Nikki Clark, "but due to these conversations, we were able to track down the documentation that the U.S. DOL requested. We have now seen that the U.S. DOL has re-opened claims and former workers are now waiting for a response."
