# **PM** IMPAIRMENTS CORNER

## New Condition Added to Your White Card? You may be eligible for an off-cycle Impairment Evaluation.

If you already have a U.S. Department of Labor (DOL) medical benefits white card under the Energy Employees Occupational Illness Compensation Program (EEOICP) and later find out you have another illness caused by your work at a U.S. Department of Energy (DOE) or Radiation Exposure Compensation Act (RECA) facility, you can ask to add this new illness to your claim. This is called adding a "covered condition."

Once the U.S. DOL agrees that your new illness is related to your job, you can get a new impairment evaluation. This is a medical exam that checks how much the illness has affected your body. A specially trained, board-certified PCM Impairments doctor can perform the impairment evaluation for you.

You don't have to wait the standard two years between evaluations if you're adding a new illness. If the new illness causes more damage to your health, you may get more compensation. The U.S. DOL

pays \$2,500 for each 1% of whole-body impairment. The government pays for this exam if it's done by a qualified physician, like one of ours, and provided it

has been authorized.

This process helps make sure you get fair compensation for all the health problems caused by your work. If you get a new diagnosis, it's important to tell the U.S. DOL and send in your medical records. More importantly, PCM Impairments can make this process simple and seamless for your convenience.
